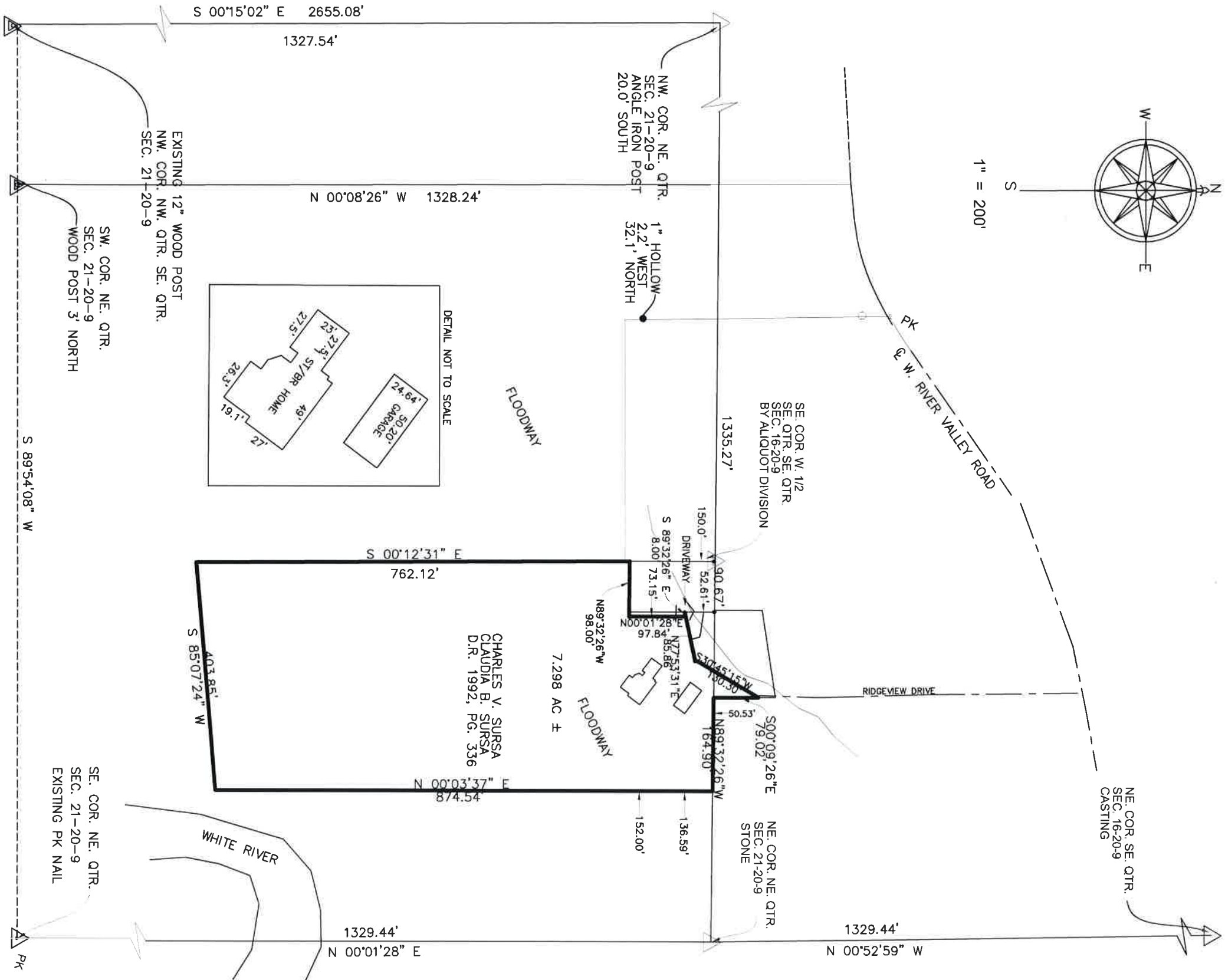



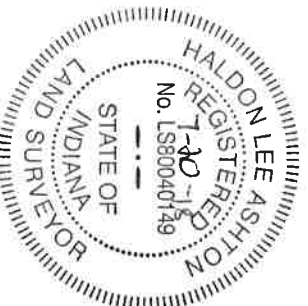
SURVEYOR'S LOCATION REPORT
